

**Privacy Policy defines the principles of processing and protection of personal data, provided by Users of the [www.ekmsp.eu](http://www.ekmsp.eu) website hereinafter referred to as the Service.**

1. The administrator of the personal data contained in the Website is the Chamber of Commerce and Industry in Katowice, located in Katowice, Opolska 15 Street, NIP 6341006202, REGON 003445317, hereinafter referred to as the Administrator.
2. The website obtains information about Users entered in the forms based on the consent given by them.
3. The data that the User provides or leaves when signing up for the services and products provided by the Administrator and when using the services and products are primarily data necessary to provide the opportunity to use the Administrator's services and products. Such data are collected and processed as: first name, last name, position, company/organization name, telephone number, organization type, company size, type of business, country, province, e-mail address, IP. Please note that as part of navigating through the Administrator's services, data is also left in so-called cookies.
4. The user who placed data in the form has the right to: a. inspect, modify, delete personal data, b. restrict processing and request to stop processing of his/her data at any time, c. withdraw consent at any time - withdrawal of consent does not affect the legality of processing performed before its withdrawal, d. transfer data to another Personal Data Administrator e. file a complaint with a supervisory authority.
5. Personal data provided by the User in the form will be processed for a period no longer than necessary for the purposes for which they were provided and until the existence of legal, accounting and tax obligations of the Administrator, as well as until the statute of limitations for possible claims. If consent has been given for process personal data - until the consent is withdrawn.
6. The Administrator shall exercise due diligence to adequately secure the personal data provided, and in particular against their access to unauthorized persons unauthorized persons.
7. The personal data provided may be made available only to entities that have legal basis resulting from the provisions of the Polish law.
8. The entities that collect and process personal data on the website are mainly from Poland and countries in the European Economic Area (EEA). Some of the providers are based outside the EEA (e.g. Google Inc. is based in the USA and provides a website statistics service called Google Analytics). These providers are required to comply with the principles set forth under the EU-US Privacy Shield program regarding the collection, use and storage of personal data of European Union citizens (Commission Implementing Decision (EU) 2016/1250 of July 12, 2016 on the adequacy of protection provided by the EU-US Privacy Shield) and contractual clauses adopted by the EU Commission.
9. Legal bases related to the processing of personal data: a. Law of July 18, 2002 on the provision of electronic services (uśude); b. Law of July 16 2004 Telecommunications Law (PrTel); c. Regulation 2016/679 of the European Parliament and of the Council (EU) of April 27, 2016 on the protection of natural persons in connection with the processing of personal data and on the free flow of such data and repealing Directive 95/46/EC; (GDPR).
